From October 15 to 18, 2016, more than 500 members of the healthcare community gathered in Denver, Colorado for the **2016 Annual Primary Care Conference**, jointly hosted by Community Health Association of Mountain/Plains States (CHAMPS) and Northwest Regional Primary Care Association (NWRPCA). This year's conference theme was "Full Circle: Rooted in Our Future," reflecting on our shared foundation of providing valuable and comprehensive community-based care, and recognizing how our mission to realize community health, wellness, and well-being influences our motivation moving into the future. Keynote speakers included Charlene Frizzera, President of CF Health Advisors, and Roberto Dansie, PhD, Founder and President of Cultural Wisdom. Margaret Davis, MSW, shared an update from the Bureau of Primary Health Care (BPHC) and Dan Hawkins gave an update from the National Association of Community Health Centers (NACHC). CHAMPS, NWRPCA, and Western Clinicians Network (WCN) partner each year to host this conference in alternating regions. Next year's Annual Primary Care Conference will be held October 21-24, 2017 in Seattle, WA.

Congratulations to the 2016 CHAMPS Award Winners!



Region VIII Health Centers Receive Additional HHS Support

In September 2016, US Department of Health and Human Services (HHS) Secretary Sylvia M. Burwell announced \$87 million in funding for enhancements in health center information technology. Sixty-seven health centers in Region VIII received funding totaling \$3,906,243. According to HHS, this funding will support health information technology enhancements to accelerate health centers' transition to value-based models of care, improve efforts to share and use information to support better decisions, and increase engagement in delivery system transformation. This is the first significant investment since 2009 directly awarded to health centers to support the purchase of health information technology. Spanish Language Training to be held April 21 to 24, 2017



CHAMPS, in partnership with Denver Medical Society, has set the date for the annual medical <u>Spanish Language Training</u> for clinicians and clinical support staff at Region VIII health centers. This four-day course is an intensive, conversational and medical Spanish workshop consisting of medical dialogues, role-plays, visual aids, cross-cultural discussions, and daily practice. The course curriculum provides an experience of

immersion learning, an approach that is highly suitable for those with limited time, and who must use their new language skills immediately with their Spanish-speaking patients. Three skill levels will be offered, with separate classes for each level. Registration information will be available in early 2017.

New CHAMPS Breastfeeding Resources

The US Preventative Services Task Force (USPSTF) recently released an <u>updated recommendation</u> on primary care programs to promote breastfeeding. The paper cites that while breastfeeding provides substantial health benefits to children and additional benefits to mothers, nearly half of all mothers who initiate breastfeeding stop before the baby reaches six months of age. This falls short of the recommended breastfeeding duration from many national and international organizations including American Academy of Pediatrics, American College of Obstetrics and Gynecology, American Association of Family Physicians and the World Health Organization. The largest disparities in breastfeeding duration outcomes are found among young mothers and those from disadvantaged communities.

The good news is USPSTF found commonly used primary care interventions supporting breastfeeding, including professional support, peer support, and formal patient breastfeeding education, were all effective means of changing breastfeeding behaviors. METx App Helps Doctors Treat Opioid Addiction

Almost 2.5 million Americans have an opioid use disorder, but only 20 percent of them receive treatment. In order to address this public health crisis, the Substance Abuse and Mental Health Services Administration (SAMHSA) developed the MATx app. Drawing on data from SAMHSA, MATx connects doctors and patients immediately to a locator tool



that finds the nearest qualified opioid use disorder treatment center. This regularly-updated app is available on iOS and Android operating systems. MATx is designed to be a physician's top resource for finding instant, qualified treatment options when working with a patient who may suffer from an opioid use disorder.

- ★ Partner with local organizations to host an enrollment or educational event
- ★ Display information in your organization that advertises Open Enrollment
- ★ Share Marketplace information through social media

Health Outreach Partners' Transportation Initiative

Launched in March 2016, <u>Health Outreach Partners'</u> (HOP) <u>Transportation Initiative</u> seeks to document the impact of transportation barriers on healthcare costs and to strengthen patient-centered transportation solutions. The initiative consists of two key projects: **Rides to Wellness Community Scan** and **Not Just A Ride**. As part of these projects, HOP invites health centers to <u>participate</u>

<u>in a survey</u> to quantify the costs of missed appointments due to transportation barriers. Additionally, HOP has recently released two new transportation-related resources: <u>"Transportation and Health Access: Where Are We Now and Where Do We Go?"</u> and <u>"Transportation and Health Access: A Quality Improvement Toolkit."</u>

Lyft Offers Discounted Rides to Attend Enrollment Events: Lyft is a ride-sharing company that now operates in several cities in Colorado and Utah. This open enrollment season, new Lyft riders can receive \$10 off two rides using the code GETCOVERED in the Lyft app.

Medical-Legal Partnerships Promote

The Rural Health Information Hub's Rural Monitor recently published "Bringing Law and Medicine Together to Help Rural Patients," an article written by Allee Mead that demonstrates the value medicallegal partnerships (MLPs) can bring to their patients and communities. The article shares the story of how one health center patient, fearful that her abusive husband would find out if she went to the community's Legal Aid office, instead approached the health center's on-site attorney for legal help during her visit to the dentist.

The article states, "Much of a person's health is determined by environmental and social factors such as housing or access to healthcare. The average low-income individual deals with two or three healthharming legal needs at a time." Through addressing not only physical well-being, but also providing integrated legal services, health centers can respond to social determinants of health and increase the value-based care they provide to their communities.

NACHC Partners With US Army to Recruit Veterans

On October 25, 2016, the National Association of Community Health Centers (NACHC) and the US Army



signed an agreement to provide priority hiring status to qualified soldiers who participate in the Partnership for Youth Success (PaYS) program. The ArmyPaYS program is a strategic partnership between the US Army and nearly 500 partner corporations and public sector agencies dedicated to helping Army veterans achieve success once they complete their service. The Army will provide job training, as long as the service member agrees to work for a specific partner organization once they are released.

"Health centers not only have a proud tradition of providing care to veterans, they are working hard to recruit them as part of their workforce," said Tom Van Coverden, President and CEO of NACHC. "As the national voice for health centers and the patients they serve, NACHC needs the varied skill sets that veterans possess to fill positions from top to bottom. We also need staff who can effectively and compassionately relate to diverse populations with commitment and dedication. Certainly our nation's veterans have proven they are up to the task."
