On October 19-22, 2014, more than 450 people from across the country gathered in Denver, CO to enjoy educational sessions, networking opportunities, meetings, and engaging conversations during the Community Health Association of Mountain/Plains States (CHAMPS) and Northwest Regional Primary Care Association (NWRPCA) Annual Primary Care Conference. Plenary speakers included Kim Gillan from the US Department of Health and Human Services, Dan Hawkins from the National Association of Community Health Centers (pictured at right, on the right),





Jim Macrae from the Bureau of Primary Health Care (pictured at right, on the left), Michael Lovdal from Oliver Wyman, and Julian Perez, MD from Sea Mar Community Health Centers (pictured at left). Conference attendees gained insights on outreach and enrollment, governance, pain management, PCMH, employee development, social determinants of health, revenue cycles, and much more. The conference also included a full day session on Education Health Centers and a two-day Primary Care/Public Health Inter-professional Leadership Development Institute. HHS Awards Mental Health, PCMH, and Increased Access Funding

This summer and fall, Health and Human Services (HHS) Secretary Sylvia M. Burwell announced four Affordable Care Act (ACA) grant awards to support health centers. In July, she announced \$54.6 million in grants to support health centers in establishing or expanding behavioral health services. In August, she announced \$35.7 million for patient-centered medical home (PCMH) facility improvements. In September, she announced \$295 million to increase access to primary care at health centers. In November, she announced \$51.3 million to support mental health and substance abuse services.

Congratulations to the 56 Region VIII health centers who received almost \$17 million in new funding!

- **★** Three years of progress toward eight selected **Healthy People 2020 (HP2020) Goals** including **NEW** data on the **colorectal cancer screening** measure.

CHAMPS 2014 Salary Survey Report Published

CHAMPS thanks the 51 organizations that participated in the **CHAMPS 2014 Region VIII Health Center Salary, Benefits, and Turnover Survey!** The data from these health centers has been analyzed and presented in a written report providing a regional snapshot of salary and benefits structures and workforce trends across the Mountain/Plains states, including:

- ★ **NEW** Job Description Summaries for every title in the report, to ensure health centers reported their data under the most appropriate positions and are utilizing the most appropriate data when referring to the report
- ★ Base salary data for each position title (average, median, and percentiles) with average dollar amount of benefits and average benefits as a percentage of average salary
- ★ Data breakdowns for all titles by three annual budget ranges
- ★ Data breakdowns for Administrative and Clinical Leadership Team and Clinical Team employees by years of service, number of service sites, annual budget range, and location
- ★ Data breakdowns for select support staff employees by years of service
- ★ Comparisons of 2014 Region VIII salary data with historical Region VIII data, as well as with other current state, regional, and national surveys
- ★ NEW section of information about additional pay (bonuses, incentives, differentials, overtime)
- ★ **NEW** section of information about health center benefits packages (insurance, retirement programs, days off, and additional benefits)
- * Recruitment metrics and trends, including point-in-time vacancy data for executive-level administrators, provider staff, and mid-level clinicians

In the most recent National Health Service Corps (NHSC) loan repayment award cycle, **Region VIII clinicians received almost \$11.5 million in loan repayment awards**. NHSC selected 99 applicants from Colorado, 101 applicants from Montana, 29 applicants from North Dakota, 23 applicants from South Dakota, 94 applicants from Utah, and 24 applicants from Wyoming to receive loan repayment awards. During the spring and summer of 2014, CHAMPS undertook a survey of Region VIII's community, migrant, and homeless health centers to collect data to publish the **2014 CHAMPS Region VIII Salary, Benefits, Turnover, and Vacancy Survey Report** (see page 5 for details).

The upcoming webcast, 2014 Region VIII Health Center Workforce Data: Understanding and Utilizing Workforce Statistics from the 2014 CHAMPS Region VIII Salary, Benefits, Turnover, and Vacancy Survey Project, is designed to assist Region VIII health centers utilize the report and understand the data it contains. Andrea Martin, CHAMPS Workforce Development and Member Services Director, will explain the history and methodology of the survey and highlight findings relating to salaries and benefits for all health center staff, including a NEW look at base vs. additional pay and the structure of health center benefits packages. She will also address trends in additional workforce metrics including vacancies, turnover, and challenging areas of recruitment and retention, and will present NEW analysis of data relating to medical provider vs. support staffing ratios and medical provider productivity expectations.

MPCN Steering Committee Plans for 2015-2016 and **Elects New Officers**

The Mountain/Plains Clinical Network (MPCN) Steering Committee met on Saturday, October 18, 2014 to create the 2015-2016 MPCN Strategic Plan. During this strategic planning session, the MPCN Steering Committee determined that the overarching goals of MPCN during 2015-2016 should be to provide education, training and resources, to increase awareness communicate the value of MPCN, to build and nourish partnerships, and to keep MPCN informed about the changing **health care landscape**. In determining these main goals, Steering Committee members reviewed the MPCN mission, accomplishments during 2013-2014, responses to a SWOT (strengths, weaknesses, opportunities, and threats) survey completed by Steering Committee and CHAMPS staff members, and recent changes in the health care industry and health center practices.

Before strategic planning, the MPCN Steering Committee elected new officers. For the next two years, Kim McFarlane, PA-C, Medical Director at Green River Medical Center in Green River, UT, will serve as the Chair, and Chastity Dolbec, RN, BSN, Director of Patient Care and Innovation at Coal Country Community Health Centers in Beulah, ND, will serve as the Vice-Chair. CHAMPS and the Steering Committee thank Keith Horwood, MD as the outgoing Chair and Pat Powell, MD as the outgoing Vice-Chair.

The MPCN Steering Committee currently has openings for medical, dental, and behavioral health representatives from Montana

and South Dakota, dental representatives from Wyoming and Utah, and a behavioral health representative from Utah.

Updated Region VIII Data Now Available

CHAMPS recently updated the Region VIII Demographics Data **Summary**, providing useful statistics from each Region VIII state with comparisons to national data including information about total population, ethnicity, disability status, per capita income, and more. Some interesting findings include:

- ★ The percentage of the total population under the age of five years that speaks a language other than English in the home decreased in Colorado, Montana, South Dakota and Utah, but increased in North Dakota and Wyoming.
- ★ The percentage of the total population that are of Hispanic or Latino ethnicity has increased in every Region VIII state.

MPCN NEWS, Continued

New Report Discusses the Effectiveness of Long-Term Opioid Therapy for Chronic Pain

In September 2014, the Agency for Healthcare Research and Quality (AHRQ) published **The Effectiveness and Risks of Long-Term Opioid Treatment of Chronic Pain**, a systematic review of the current evidence on long-term opioid therapy for chronic pain. The results were used to inform the National Institutes of Health (NIH) workshop, **Pathways to Prevention: The Role of Opioids in the Treatment of Chronic Pain**. A key finding in the report was that the confidence level in the efficacy of long-term opioid therapy was ranked "no higher than low." Another finding was that long-term opioid therapy was associated with increased risk of abuse, overdose, fracture, myocardial infarction, and markers of sexual dysfunction, with several studies showing a dose-dependent association.

CHWs are people who promote health in their own communities by providing leadership, peer education, and resources to support community empowerment. As members of minority and underserved populations, they are in a unique position to

School-Based Health Center Census Participation Request

Every three years, the **School-Based Health Alliance** conducts a national census of school-based health centers (SBHCs) to collect information about school-based health center staffing, health services, prevention activities, utilization, financing, and sustainability. The data illustrates how SBHCs are growing and evolving and allows organizations like School-Based Health Alliance and their state affiliates to better advocate for more support for SBHCs on the state, local, and federal levels. The **2013-14 SBHC Census** is now open, and the Alliance hopes that every SBHC in the Mountain/Plains states will participate. The census takes 30-45 minutes to complete. Each year the National Association of Community Health Centers (NACHC) recognizes exemplary leaders from across the nation. This past August, a long-time Region VIII community health center staff member was honored at the NACHC Community Health Institute (CHI) held in San Diego, CA.

Paul Melinkovich, MD (retired, pictured at left) from Denver Community Health Services in Colorado received the 2014 Samuel U. Rodgers Achievement Award for exemplifying excellence in clinical leadership. HRSA Releases Sliding Fee PIN

In September 2014, the Health Resources and Services Administration (HRSA) issued the final policy on "Sliding Fee Discount and Related Billing and Collection Program Requirements" (Policy Information Notice [PIN] #2014-02). The new policy, which applies to health center grantees and FQHC look-alikes, clarifies aspects of the sliding fee discount program, including the establishment of a schedule of fees for services, a corresponding schedule of discounts for eligible patients that is adjusted based on the patient's ability to pay, governing board-approved policies, and the organization's supporting operating procedures around billing and collections.

Region VIII Health Center Receives Grant to Expand Access and Improve Care

In August 2014, **Utah Navajo Health System (UNHS)** in Montezuma Creek, UT, was one of seven healthcare organizations nationally to receive a **Helping Build Healthy Communities** grant. "BD Helping Build Healthy Communities" is a multi-year initiative that expands access and improves care for underserved and vulnerable populations. The initiative is funded by BD, a medical technology company, and implemented together with Direct Relief and the National Association of Community Health Centers (NACHC). It provides awards to clinics and Community Health Centers delivering innovative models of care.

UNHS was awarded the \$100,000 grant for their work in developing a collaborative practice agreement between its medical providers and four clinical pharmacists where providers can refer patients to pharmacists for increased education, follow-up, and medication management for the treatment of diabetes and related conditions. Once patients are referred, the clinical pharmacist meets with the patient for an initial evaluation and needs assessment to evaluate the patients' educational needs, goals, family/social structure, health beliefs, and cultural or language characteristics. Education about self-care, patient-empowerment, and how to live a healthy life is then provided to the patient though the pharmacist on an ongoing basis. These enhanced pharmacist visits help reduce costs and complications by preventing unnecessary ER visits and hospital stays, acute infections, avoidable kidney disease, and eye surgeries that might be needed as a result of the patients' diabetes.

Montana and Wyoming Health Centers Receive Grants to Implement Depression Care Model

In May 2014, the John A. Hartford Foundation awarded grants to **Bighorn Valley Health Center** in Hardin, MT, **Community Health Center of Central Wyoming** in Casper, WY, **Partnership Health Center** in Missoula, MT, and **Southwest Montana Community Health Center** in Butte, MT to improve care for depression. The Foundation funding from the Corporation for National and Community Service provided the health centers with a combined award of \$1,232,000 over



two years, which will enable them to implement IMPACT (Improving Mood – Promoting Access to Collaborative Treatment). This evidence-based care model has been shown to double the benefits of depression treatment.
