

Attention PECS Users!

The developers of the Patient Electronic Care System (PECS), along with the Clinical Advisory Group (CAG) are currently attempting to create a priority list for interfaces with several Electronic Medical/Health Record Systems, lab providers, and practice management systems. These interfaces are being created in response to the growing need for more efficient data entry in the health centers as well as their increased reliance on EMRs/EHRs. For your reference, the following list describes the current status of this innovative project:

- CliniFlow: initial contact has been made
- MDServe: in alpha (initial) testing
- Quest Diagnostics, Inc.: setting up beta test at a health center in Michigan
- Medical Manager: obtaining example output files
- MegaWest: obtaining example output files
- LabCorp: initial interface successfully implemented at a center in Texas; working on second beta test at a health center in Austin, TX

HHS Awards \$49 Million to Extend Health Care to More Low-Income, Uninsured Americans

The Department of Health & Human Services (HHS) awards, encompassing 76 new health center grants, will help an estimated 488,000 Americans obtain comprehensive primary health care services. Grantees will receive their awards in December contingent upon the availability of fiscal year 2005 funds. What does this mean for Region VIII? The money will help fund Metro Community Provider Network (MCPN), and has enabled the existence of the new Cheyenne Health and Wellness Center in Wyoming. Welcome to Region VIII! Rocky Mountain Regional Care Model for Bioterrorist Events

The Agency for Healthcare Research and Quality (AHRQ) has released a tool to help State and local officials quickly locate alternate health care sites if hospitals are overwhelmed by patients due to a bioterrorism attack or other public health emergency. J-1 Visa Program May be Extended another Two Years

The current J-1 Visa Program, enacted eight years ago, expired May 31st. However, under a bill (H.R. 4453) approved by a House Committee at the end of September, the program – which allows certain government agencies to request a waiver of the two-year home residence requirement for physicians who agree to practice in underserved areas for three to five years - would continue through FY 2006. The bill, sponsored by Rep. Jerry Moran (R-KS) also clarifies that doctors granted dispensation under the program would not count against limits on H1-B visas, which are used for highly skilled foreign workers. A companion measure (S. 2302) is awaiting action in the Senate.
