Recent CHAMPS Strategic Planning

During the recent NWRPCA/CHAMPS Annual Primary Care Conference, the CHAMPS staff and Executive Committee met to participate in strategic planning, the results of which will guide CHAMPS offerings for the upcoming three years. Participants utilized results from the fall CHAMPS Strategic Planning Survey that collected input from senior leadership staff at Region VIII health centers and Primary Care Associations, and the process focused on re-evaluating the CHAMPS Mission, Vision, and Values, defining strategic goals, and determining the strategic intent and objectives for each identified goal area. As a result of this process, CHAMPS has approved updated versions of the Mission, Vision, and Values and identified four strategic goal areas. Strategic intent and objectives for the goal areas remain in the draft stages, and will be incorporated into the finalized CHAMPS Strategic Plan to be approved by the CHAMPS Executive Committee.

Updated CHAMPS Mission:

To provide opportunities for education and training, networking, and workforce development to Region VIII community health centers so we can better serve our patients and communities.

Updated CHAMPS Vision:

All patients and communities benefit from the impact of the resources that CHAMPS provides to community health centers.

CHAMPS Strategic Goal Areas:

Branding, Education and Training, Networking, Regional Advocacy

Funding Supports Region VIII Community Health Centers

At the end of September, Health and Human Services (HHS) Secretary Kathleen Sebelius announced several grant awards that will benefit health centers across the nation.

Health Information Technology: \$27.8 million was awarded to implement electronic health records and other health information technology, with the intent to reduce waste in the system and improve the safety and quality of healthcare for the growing number of health center patients.

Outreach and Enrollment for Children: \$40 million was awarded to organizations that target geographic areas with high rates of uninsured children who are eligible for either Medicaid or the Children's Health Insurance Program (CHIP). The grants will be used to seek out eligible children and help families with the application process.



Coming Soon: Region VIII UDS Summary with NEW Focus on Health Center Business Plan Measures!

Each year CHAMPS publishes a summary of Region VIII Uniform Data System (UDS) information, including a five year trend of CHC users, staffing, encounters, and income figures. In 2009 this report will be enhanced to include a three-year trend comparing Region VIII and national figures for **total cost per patient** and **medical cost per medical encounter**, two Health Center Program Business Plan Performance Measures. Also included will be selected factors relating to these performance measures, including a focus on special populations, user language preferences, location, and enabling services, with comparisons to overall encounters, patients, and revenue. This publication will be distributed soon after the Health Resources and Services Administration (HRSA) releases the 2008 Regional and National UDS reports.

Funding Supports Health Center Workforce

In October 2009, 28 awardees received \$5.3 million in funding from the American Recovery and Reinvestment Act (ARRA) to support the **Student/Resident Experiences and Rotations in Community Health (SEARCH) Program**. SEARCH was created to foster partnerships between academic institutions and community health centers so that both students in the health professions and

residents have the opportunity to serve on health care teams in underserved communities.

In September 2009, more than \$7.6 million in ARRA funds were awarded to address workforce shortages and encourage diversity in the health professions. Almost \$6 million was distributed under the **State Loan Repayment Program (SLRP)**, to increase the availability of primary health service providers in health professional shortage areas. Another \$1.8 million went to State Primary Care Offices (PCOs) to help those PCOs **recruit new National Health Service Corps (NHSC)** clinicians.

The National Health Service Corps (NHSC) has announced that it is **simplifying its application process**, revising its Applicant Information Bulletin (AIB), and shortening its application checklist. The new application procedure will require fewer documents, has streamlined instructions, and the website now contains fillable forms. The AIB has been simplified as well, making it easier for applicants to find information and is now available in HTML and PDF formats.

Fall 2009 Teleconference on H1N1

On September 16, 2009 Community Health Association of the Mountain Plain States (CHAMPS), Colorado Community Health Network (CCHN), and Colorado Children's Immunization Coalition (CCIC) hosted the **Fall 2009 Immunization Update Teleconference: NOVEL INFLUENZA A (H1N1)**. The program was presented by John Ogle, MD; Simon Hambidge, MD; Matthew Daley, MD; and Nancy Gilbert, and had the following learning objectives:

- Understand the epidemiology and clinical features of Novel Influenza A (H1N1)
- ★ Learn the current status of transmission of H1N1 in the US and around the world
- Understand how H1N1 is diagnosed, particularly in the primary care setting
- ★ Learn the treatment recommendations for H1N1
- Hear talking points for communicating information about H1N1 to patients

Over 345 people participated, making this the most well attended CHAMPS teleconference to date. The overall satisfaction rating for the teleconference was excellent, scoring an 8.5 on a scale of 1-10 with 10 being the best possible rating.

Region VIII SPCA Staffer Receives National Recognition

Jessica Sanchez, the Clinical Quality Division Director at Colorado Community Health Network (CCHN) was recently honored by the National Association of Community Health Centers (NACHC) as the recipient of NACHC's **Henry Fiumelli Patient Advocate Award**. Jessica was chosen from a national list of nominees and will receive her award from NACHC at the Annual PCA conference in Albuquerque, NM, the week of November 15.



The award honors the late Henry Fiumelli, who served for 18 years as the Executive Director of the Pennsylvania Forum for Primary Health Care. Established in 2008, the award honors an outstanding staff member of a NACHC-chartered State or Regional Primary Care Association (S/RPCA) who exemplifies passion and commitment to improving the care and quality of life for health center patients. Ms. Sanchez recently celebrated her tenth anniversary at CCHN, working to improve access to high quality clinical care for underserved Coloradans. An excerpt from Jessica's nomination letter reads:

The Community Health Center movement in Colorado has been shaped in part by Ms. Sanchez, and her contributions as a grant writer, project director, and the countless number of direct hours treating CHC patients has undoubtedly enhanced the ability of CCHN to fulfill its mission to increase access to high quality health care for people in need in Colorado.

US Census Bureau Releases 2008 Report on Income, Poverty and Health Insurance Coverage

On September 10, 2009 the US Census Bureau (USCB) released *Income, Poverty and Health Insurance Coverage in the United States: 2008*, a report regarding 2008 income and health insurance statistics. The report indicates that the number of people both uninsured and living in poverty increased from 2007 to 2008. Although the percentage of people without insurance did not change in a statistically significant way, the dynamics of how these people are being covered has shifted notably.



The number of people **without health insurance coverage** nationally increased to 46.3 million in 2008, up from 45.7 million in 2007. There were 39.8 million people **living in poverty** in 2008, up from 37.3 million people in 2007. This represents the first statistically significant increase in poverty since 2004, and this is the nation's highest rate of poverty since 1997. **Real median household income** declined by 4.0 percent in the Midwest, and 2.0 percent in the West, and the poverty rates of both regions increased. In the Midwest, the poverty rate was 12.4 percent in 2008, up from 11.1 percent in 2007. The West's poverty rate increased to 13.5 percent in 2008, up from 12.0 percent in 2007.

HRSA Launches YouTube Channel

On October 1, 2009, the Health Resources and Services Administration (HRSA) launched a YouTube channel, **HRSAtube**, highlighting its work around the nation through visual media. Videos include clips from HRSA leaders at national meetings and two video series of personal testimony from HRSA fund recipients.

In a short video series titled, "National Health Service Corps: A Story of Heroes" healthcare professionals working in rural communities are interviewed. One clip features **Regina Benjamin**, **MD**, a former National Health Service Corps (NHSC) scholar and recently appointed US Surgeon General, working in Bayou La Batre, AL. In a clear declaration of appreciation for her work Dr. Benjamin says, "I don't feel like I am giving to the community, I think they are giving to me. I get much more out of seeing patients and treating them everyday."

Another series is a collection of short interviews taped at the 2009 Grantee Partnership Meeting in Washington, DC. Grant recipients from Hawaii to New Jersey express appreciation for the opportunities HRSA funding has provided for their local communities, highlighting a wide breadth of programs. Interviewees repeatedly express how HRSA funding has increased their patient's access to primary care by providing more health professionals within a shorter distance to their communities.

Office of Performance Review Changes Name

On September 21, 2009 the Health Resources and Services Administration (HRSA) Office of Performance Review (OPR) announced that it has been renamed the **Office of Regional Operations (ORO)**, effective immediately. The new name reflects how the office has expanded to include additional tasks that are designed to enhance HRSA's presence in the regions. These include, but are not limited to:

- Working to increase access to health care, reduce disparities and improve public health by forming national partnerships;
- ★ Addressing common goals by building and strengthening collaborative partnerships with State governments and communities;
- ★ Assisting grant recipients who are in partnership with HRSA;
- ★ Increasing activities to recruit and retain health professionals;
- ★ Analyzing and monitoring health care trends.

Regan Crump will continue in his role as Associate Administrator, and all 10 Regional Offices will continue with their present leadership.

The Colorado Health Institute (CHI) has released two new resources providing fact-based, objective, and non-partisan information about health care reform. 

- The UDS Training schedule lists the dates and locations of various UDS Training sessions available to grantees for reporting on the 2009 UDS data. The trainings highlight the new process for UDS reporting that includes the opportunity for technical assistance prior to a grantee's submission of the 2009 UDS Report due by March 31, 2010.

The Department of Health and Human Services (HHS) recently created the Communities Putting **Prevention to Work** initiative, funded through the American Recovery and Reinvestment Act (ARRA), to reduce risk factors, prevent/delay chronic disease, promote wellness in children and adults, and provide positive, sustainable health change in communities. Under the **Community Initiative** portion of this program, nearly \$450 million will be distributed for intensive community approaches to chronic disease prevention and control in selected communities (urban, rural, and tribal). This money will include grants to communities (\$373 million), as well as provide community support and evaluation support (\$76 million). Cooperative agreements for the Community Initiative Program will be awarded to communities through a competitive selection process; the application deadline is December 1, 2009.
