CHAMPS NEWS, CONTINUED

Funding Supports Region VIII Community Health Centers

At the end of September, Health and Human Services (HHS) Secretary Kathleen Sebelius announced several groups of grant awards that will benefit health centers across the nation.

<u>Health Information Technology</u>: \$27.8 million was awarded to implement electronic health records and other health information technology, with the intent to reduce waste in the system and improve the safety and quality of healthcare for the growing number of health center patients.

<u>Outreach and Enrollment for Children</u>: \$40 million was awarded to organizations that target geographic areas with high rates of uninsured children who are eligible for either Medicaid or the Children's Health Insurance Program (CHIP). The grants will be used to seek out eligible children and help families with the application process.

<u>Support of Health Professionals</u>: More than \$7.6 million in Recovery Act funds were awarded to address workforce shortages and encourage diversity in the health professions. Almost \$6 million was distributed under the State Loan Repayment Program, to increase the availability of primary health service providers in health professional shortage areas. Another \$1.8 million went to State Primary Care Offices (PCOs) to help those PCOs recruit new National Health Service Corps (NHSC) clinicians.
