On October 14-17, 2012, **more than 400 people** from across the country gathered in Denver, CO, to enjoy educational sessions, networking opportunities, meetings, and engaging conversations during the Community Health Association of Mountain/Plains States (CHAMPS) and Northwest Regional Primary Care Association (NWRPCA) Annual Primary Care Conference. Plenary speakers included Gov. John Hickenlooper of Colorado, Dr. Mary Wakefield, Dan Hawkins, Marguerite Salazar, and T.R. Reid.

Participants gained insights on designing health centers, board engagement, policy changes, HR best practices, meaningful use, clinic operations, federal updates, and other valuable topics. The conference theme of implementing healthcare reform was echoed throughout the sessions and meetings. CHAMPS, NWRPCA and Western Clinicians Network (WCN) partner to host the conference each year in alternating regions. ### Region VIII Health Centers Awarded Quality Improvement Supplemental Funding

In September, Health and Human Services (HHS) Secretary Kathleen Sebelius announced new grants from Affordable Care Act (ACA) funds that will help 810 community health centers become patient-centered medical homes (PCMHs) and increase their rates of cervical cancer screening. Forty of these grantees come from Region VIII, including eleven from Colorado, ten from Montana, three from North Dakota, five from South Dakota, nine from Utah, and two from Wyoming. **Congratulations to all the grantees!**

### **CHAMPS 2012 Salary Survey Report**

CHAMPS thanks the 46 organizations that participated in the **CHAMPS 2012 Region VIII Health Center Salary, Benefits, and Turnover Survey!** The data from these health centers has been analyzed and presented in a written report providing a regional snapshot of salary and benefits structures and workforce trends across the Mountain/Plains states, including:

- ★ Salaries for each position title at 10th, 25th, 50th (median), average (mean), 75th, and 90th percentiles, as well as average dollar amount of benefits and the average benefits as a percentage of salary Breakdowns of salary and benefits information for all titles by annual budget range
- ★ Breakdowns of salary information for leadership team and clinical team staff by years of service, budget range of organization, and location
- ★ **NEW** breakdowns of salary information for administrative and clinical support staff by years of service
- ★ Comparisons of 2012 Region VIII salary data with historical Region VIII data and other state, regional, and national surveys
- \* Recruitment metrics and trends, including point-in-time vacancy data for executive-level administrators, provider staff, and mid-level clinicians
- ★ Retention metrics and trends, including turnover data for all staff

### **Mid-Level Managers Present Project Outcomes**



In October 2012 CHAMPS and Northwest Regional Primary Care Association (NWRPCA) concluded **Critical Skills for Mid-Level Managers**, a six-month hybrid course designed to improve the ability of health center supervisors to lead successful teams in their clinics. Thirty-one mid-level (non-executive) managers from Regions VIII and X began their journey in April with a two-and-a-half day face-to-face training in Denver, and continued their learning at their home health centers through targeted mentorship, work on capstone projects, and attendance on calls and webinars designed to share challenges and successes while continuing their education. Led by Lisa Mouscher of Sogence Training and Consulting, sixteen participants reconvened at a day-long session (pictured at left) during the recent CHAMPS/NWRPCA Primary Care Conference to present the outcomes of their capstone projects and learn how to independently continue their professional development after the conclusion of the course.

### "If Only Someone Had Told Me...": Lessons From Rural Providers

Originally published in the Journal of Rural Health in Winter 2011, this report sought to identify ways to enhance training, improve recruitment, and increase retention for rural practitioners. The data was gathered from focus groups of rural practitioners including physicians, physician assistants, nurse practitioners, nurses, counselors and social workers in Alaska and New Mexico. The study categorized the findings into themes representing the **challenges**, **adaptations**, **and rewards of being a rural practitioner**.

### **Change in NHSC Continuing Contract Policy**

The National Health Service Corps (NHSC) approach to processing Continuation Contract applications has been changed. Applications will now be processed during **three defined time periods** throughout the year instead of year-round. The new cycles are as follows:

If NHSC LRP service will be complete between:	Time Period to apply for Continuation Contract:
September 30, 2012 – December 30, 2012	July 1, 2012 – October 18, 2012
December 31, 2012 – May 30, 2012	January 15, 2013 - February 19, 2013
May 31, 2013 – September 29, 2013	April 30, 2013 – May 28, 2013

# Providers Share and Learn Best Practices at the CHAMPS/NWRPCA Primary Care Conference

Health care providers and other clinical staff from 13 different states networked, shared successes and challenges, visited exhibitors, and learned from experts at the 2012 CHAMPS/NWRPCA Primary Care Conference. Following is a summary of some of the clinical teachings and lessons learned at the conference:

- ★ Two providers from Clinica Family Health Services (CO) illustrated how group visits can be extremely productive. Patients often learn best from each other and the provider has the opportunity to check-in with many patients during one visit. Group visits tend to work best for specific conditions such as pregnancy, time-specific happenings such as flu clinics, or chronic conditions such as diabetes.
- ★ Dentists with the National Network for Oral Health Access (NNOHA) shared **how to integrate oral health into a Patient Centered Health Home**. Providers and staff
  across disciplines should regularly communicate, share patient information, standardize
  processes, and monitor relevant integration measures.
- ★ Dr. Winston Wong, Medical and Community Benefit Director at Kaiser Permanente, shared his ruminations on social determinants of health and the Patient Centered Medical Home. He discussed addressing disparities through a range of interventions, considering how the level of intervention would coincide with the level of determinants contributing to the patient's condition.
- \* At the Clinicians Roundtable, providers discussed topics including how to disseminate information to clinicians, patient clinic visit summaries, advanced access, patient portals, provider/CEO relations, Stay Interviews versus exit interviews, and What's Keeping Us So Busy in Primary Care?, an article from The New England Journal of Medicine.





# 13 Health Centers Join National Integration Learning Community

In September, the National Association of Community Health Center (NACHC) and SAMHSA-HRSA Center for Integrated Health Solutions (CIHS) announced the CIHS-NACHC Behavioral Health Integration Learning Community developed to address behavioral health service gaps in the healthcare safety net. This nine-month learning community will assist 13 federally qualified health centers (FQHCs) in developing their behavioral health service capacity. **Congratulations to three Region VIII health centers participating in this initiative**: Custer County Community Health Center, Inc., Flathead Community Health Center, and Northwest Community Health Center, all from Montana. The new deadline to transition to ICD-10 is **October 1, 2014**. In preparation for the transition, the Centers for Medicare & Medicaid Services (CMS) is offering several resources for providers including document online Understanding the Basics to help begin the process. CMS also offers handbooks, which contain guides for large practices, hospitals, and small/medium small provider practices as well as appendixes with templates available for download to clarify staff roles, set internal deadlines and responsibilities, and assess vendor readiness.

# Request for Comments: New Methodology for Designating US Frontier Areas

The Health Resources and Services Administration (HRSA) is seeking comments on a **new proposed methodology for identifying frontier areas**, which may have implications on the grants that rural and frontier health centers receive. Currently, the most common standard used is to label counties with six or fewer people per square mile as frontier areas. The new proposed methodology is derived from the Frontier and Remote (FAR) system as a collaborative project between the Office of Rural Health Policy (ORHP), HRSA, and Economic Research Service (ERS). HRSA is encouraging the public to submit written comments on this new system no later than January 4, 2013.
