JOB Data Comparison Report Highlights Recruitment Trends

The CHAMPS online Job Opportunities Bank (JOB) is a free resource advertising career opportunities in Region VIII health centers and Primary Care Associations. Each spring, CHAMPS compiles data submitted to JOB to create a comparison report of the health center-specific data from year to year. This annual report illustrates recruitment efforts and trends throughout Region VIII, including types of positions recruited, average recruitment lengths, and successful recruitment resources. Highlights from the February 1, 2012 to January 31, 2013 data include:

- * Forty-five different Region VIII health centers advertised 271 career opportunities on JOB during the 2012-2013 period.
- When looking at all positions that were closed in the past year (including those filled, withdrawn, and those of unknown status), the average recruitment lengths increased for Administrative/Management, Clinical Support, and Non-Clinical Support positions, but decreased for Clinical Medical and Behavioral Health positions.
- ★ Over 42% of the health center postings in the 2012-2013 period were reported as having been filled, a decrease from the 54% reported as filled in the previous year.
 - ★ However, **50% of Physician postings were reported as having been filled** in the 2012-2013 period, an increase from 30% the previous year.
- * When looking at **medical and dental postings** that were closed and reported as being filled:
 - ★ Dentist and Dental Director postings had the lowest average recruitment lengths (5.5 months).
 - ★ Mid-level positions (PA/NP/CNM) had longer average recruitment lengths (7.5 months, an increase from 4.9 months the previous year).
 - Physician and Medical Director postings maintained the longest average recruitment lengths (10.8 months, a 27% decrease from last year's average of 14.8 months).
- ★ The top 4 recruitment resources were internal hire, online listing, local referral/word of mouth, and employee referral, representing almost 77% of the known recruitment resources cited for filled postings.

New Certification Requirements for Medical Examinations of CMV Drivers

The National Registry of Certified Medical Examiners (NRCME) is a new Federal Motor Carrier Safety Administration (FMCSA) program. It requires that all medical examiners (MEs) who wish to perform physical examinations for interstate commercial motor vehicle (CMV) drivers be trained and certified in FMCSA standards starting on **May 21, 2014**. Health centers that perform examinations of CMV drivers will need to have at least one health care provider trained and certified to continue offering such medical exams after May 21, 2014.

Any health care provider who is licensed, certified, or registered in accordance with state laws and regulations to perform physical examinations may become a Certified ME. Providers must register on the National Registry and then complete the required testing and training. To assist providers in this process, **CHAMPS has created the** <u>Guide to Certification Requirements for Medical</u> <u>Examinations of CMV Drivers</u> that contains step-by-step instructions on how to register, train, and test to become a Certified ME, as well as national objectives and requirements.

New: Office of National Assistance and Special Populations

In mid-March, the Health Resources and Services Administration (HRSA) released a Federal Register Notice establishing the **Office of National Assistance and Special Populations (ONASP)**, combining the Offices of Training and Technical Assistance Coordination and Special Population Health. The purpose of this new office, led by Tracey Orloff, Director of ONASP, is to provide greater technical assistance support to health centers by using new technologies and listening to the needs of health centers. Additionally, the new office will serve to strengthen the focus on special populations, especially in the areas of policy and program development.



Mental Health First Aid for Rural Populations

The Substance Abuse and Mental Health Services Administration (SAMHSA) and Health Resources and Services Administration (HRSA) Center for Integrated Health Solutions has tailored the Mental Health First Aid program to rural populations and is offering it to rural communities nationwide. **Mental Health First Aid** trains individuals in a community to identify, understand, and respond to signs of mental illnesses and substance use disorders. Participants learn a five-step action plan to help individuals in crisis connect with appropriate professional, peer, social, and self-help care. The training is especially useful in rural communities where access to mental health services may be limited.

WYPCA Graduate Student Practicum Project Evaluates Region VIII Health Center UDS Data Collection & Reporting



A network of health centers committed to serving the needs of the underserved

Data collection, analysis, and reporting are central elements of the Health Center Program's requirements for all grantees. The Uniform Data System (UDS) is used to annually collect and track data on patient demographics, services provided, staffing, clinical indicators, utilization rates, costs, and revenues; a 2013 University of Montana Masters of Public Health (MPH) practicum project undertaken by Janell Porter, RN, MPH candidate, in collaboration with Patrick Monahan and the Wyoming Primary Care Association (WYPCA), provided a qualitative evaluation of Region VIII UDS data collection and reporting. Wyoming health centers have experienced limitations in their UDS data collection and reporting processes, so the project aimed to identify discrepancies and inaccuracies in Wyoming UDS data collection and reporting as well as to identify model reporting practices and successful strategies being implemented by other

Region VIII health centers. While the project will assist Wyoming health centers with implementing strategies for improved data collection and reporting, it is clear that Wyoming is not alone in experiencing challenges with accurately reporting UDS data. All of the participating health centers were able to identify and describe aspects of UDS data collection and reporting that they find challenging or difficult; they were able to explain what they feel would make data collection and reporting easier; and they were able to offer strategies for success. Ms. Porter's paper, **Region VIII Health Center Uniform Data System (UDS) Data Collection and Reporting: Challenges, Best Practices, and Recommendations**, is a summary of the practicum project including methods, results, and recommendations from Wyoming health centers, other Region VIII health centers, HRSA, and Ms. Porter for improving the accurate collection and reporting of UDS data.
