NEW 2013 Region VIII CHC Annual Measure of Finance, Operations, and Productivity

CHAMPS is pleased to announce a new partnership with CliftonLarsonAllen (CLA) to support CHAMPS member health centers through a **2013 Region VIII CHC Annual Measure of Finance, Operations, and Productivity**. The purpose of this project is to provide Region VIII health centers insight on their individual, state, and regional financial, operational, and productivity measures. The goals of data collection, analysis, and reporting are to:

- Give health centers strategic tools with which to measure the health and viability of their business against that of their peers' businesses,
- Begin to establish regional business data benchmarks over time for the purpose of evaluating operational strengths and weaknesses, and
- 3. Inform long-range training plans for CHAMPS.

The analysis and reporting for this project will be done by CliftonLarsonAllen (CLA) at **no cost to CHAMPS** <u>member organizations</u>. CHAMPS strongly encourages health centers to participate in order to develop valuable measurable trends for their individual health center, the states of Region VIII, and the region overall. In order to participate, health centers must submit a completed questionnaire, completed non-disclosure agreement, copy of their latest audit report, most recent UDS report, and most recent Federal Form 990 to CLA by **September 13, 2013**. CLA will not share your data with CHAMPS or any other entity.

HHS Awards Outreach and Enrollment and THC Funds

In July of 2013 Health and Human Services (HHS) Secretary Kathleen Sebelius announced \$150 million in grant awards (over \$7 million for Region VIII) to support health centers in enrolling uninsured Americans in health care options made available through the Affordable Care Act (ACA). With these funds, health centers are expected to hire an additional 2,900 employees to assist in **outreach and enrollment**. Additionally, \$6.5 million in supplemental funding (over \$700 thousand for Region VIII) was awarded to state and regional Primary Care Associations (PCAs) to support and coordinate the outreach and enrollment efforts of health centers.

NEW White Paper Analyzes Education Health Centers

In July 2013 the Education Health Center Initiative (EHCI), a partnership of CHAMPS and NWRPCA, published **Models of Education Health Centers**, a white paper written by Kiki Nocella, PhD, MHA. This valuable analysis of Education Health Centers provides information on three models - health center as sponsoring institution, consortium



partner, and outpatient training center. Dr. Nocella describes the structure, key business points, revenue, expense, and advantages of each model. The paper is an excellent way for health centers to obtain on overview of the different models available. More extensive information including a 90 page toolkit and documents pertaining to research, fiscal issues, legal issues, governance, administration, and accreditation process can be found on the EHCI website. Now Available: New Region VIII UDS Summary

Each year CHAMPS produces a three to five year history of Uniform Data System information and trends for Region VIII. The newly released **2008-2012 Region VIII BPHC Uniform Data System (UDS) Summary** includes:

- * Five-year regional trend data for health center **users, staffing, visits,** and **income**
 - NEW: Information for private insurance users, a look at rural vs. urban grantees, plus an entire section of tenure information for selected provider and leadership positions.
 - The five year growth in Region VIII grantees is 5.3%; in that time users have increased 14.0%, visits have increased 15.0%, and FTE have increased 25.6%.
 - In 2012, 68% of Region VIII grantees were considered rural, while 48% of national grantees are considered rural; almost 42% of Region VIII health center users were uninsured, compared to 36% nationwide.
 - In 2012, Region VIII average tenure per person for Family Practice Physicians and Physician Assistants was the same as for those positions nationwide. Region VIII reported longer average tenure for Nurse Practitioners and Nurses than the nation overall, but shorter average tenure for dentists, dental hygienists, and leadership positions (CEO, CMO, CFO, CIO).
- Three-year comparisons of Region VIII and national figures for two fiscal performance measures: total cost per patient and medical cost per medical visit, including a look at factors impacting these costs
 - While Region VIII's figures for the financial performance measures are higher than the nation's for 2012, Region VIII had smaller growth in those measures from 2011-2012 than the nation overall.
- Three-year comparisons of Region VIII and national figures for diabetes and hypertension health outcomes and disparities
 - In 2012 Region VIII and the nation overall reported almost identical performance on Diabetes and Hypertension measures.
- Three years of progress toward seven selected Healthy People 2020 (HP2020) Goals
 - NEW: Data on tobacco assessment and tobacco intervention measures.
 - In 2012 Region VIII health centers met four of the seven listed HP2020 goals.
 - Between 2011 and 2012, Region VIII improved performance on four measures.

First-Time Supervisors and Managers Develop Practical Skills at CORE Competency Training

During the spring and summer of 2013, CHAMPS hosted the first **CORE Competency Training for First-Time Managers and Supervisors** with support from the Wyoming Primary Care Association (WYPCA) and Colorado Community Health Network (CCHN). The course, led by Lisa Mouscher of Sogence Training and Consulting, was designed to assist first-time supervisors and managers gain the core competencies necessary to successfully navigate a supervisory or

management role in a health care setting. Beginning with the three-day training in Westminster, CO in April 2013, participants learned about transitioning from a peer to supervisor, behavioral interviewing, communication skills, leading teams, employment law, and performance management. The discussion continued with a follow-up conference call, one-on-one coaching sessions, additional CHAMPS training materials, and a LinkedIn discussion group. Participants gave the training rave reviews, and expressed

Questions about the Impacts of the ACA and PCMH on Workforce Efforts? Check out these CHAMPS Archived Webcasts.

CHAMPS partnered with NWRPCA and the state Primary Care Associations (PCAs) of Region X to host a July 2013 webcast series on the impacts of the Affordable Care Act (ACA) and Patient-Centered Medical Home (PCMH) on heath center human resources and workforce efforts. The first event, **The Emerging Health Center Workforce Environment**, focused on the key workforce components of the ACA, including Graduate Medical Education (GME), Teaching Health Centers (THC), and the National Health Service Corps (NHSC), addressing changes in these programs, anticipated future updates, and ways to maximize how health centers are using each. The second, **HR's Role in Building an Effective PCMH**, examined how data requirements and initiatives regarding PCMH will impact workforce development, new positions needed to address PCMH changes, recruiting practices that will support PCMH teams, and ideas to encourage leadership to support these changes. Participants benefited from a wealth of additional resources, including NHSC materials, sample job descriptions, employee engagement materials, and more. New Studies Address Health Workforce Planning & Needs

Health center staff interested in trends and issues in health workforce may be interested in several recently released articles and studies:

- ★ <u>A Needs-Based Method for Estimating the Behavioral Health Staff Needs of Community Health</u> <u>Centers</u> is a July 2013 research article from BMC Health Services Research which estimates the number of behavioral health professionals that will be needed in health centers for each state and nationally given the expansion of health centers under the Affordable Care Act (ACA).
- ★ <u>Will New Care Delivery Solve the Primary Care Shortage?: A Call for More Rigorous Evaluation</u> is a June 2013 Association of American Medical Colleges (AAMC) Center for Workforce Studies article that discusses the research needed to better understand the impact of health system changes on primary care physician shortages.
- ★ Demand for Family Physicians Fuels Salary, Compensation Increases, Study Finds is a July 2013 American Academy of Family Physicians (AAFP) article discussing an MGMA survey that finds the median compensation for all primary care physicians increased by \$5,000 from 2011 to 2012, reflecting the shortage of primary care physicians and an increased demand for these physicians.

Buprenorphine Training Opportunity at the NWRPCA/CHAMPS Fall Conference

The **Half and Half Buprenorphine Training** will be offered at the NWRPCA/CHAMPS 2013 Fall Primary Care Conference on October 19, 2013 in Seattle, WA. This training is offered in two parts; the first includes 3.75 hours of **CD-based training** on substance abuse treatment, opioids, and the use of buprenorphine in treatment of opioid use disorders. This first portion of the course must be successfully completed before attending the second part of the training, 4.25 hours of **face-to-face training** on Saturday, October 19th focusing on helping trainees think through "real life" experiences in opioid use disorders treatment. The combined CD and face-to-face training provides the required eight hours needed to **obtain the waiver to prescribe buprenorphine in office-based treatment of opioid dependence**. Certification for the course is issued through the American Academy of Addiction Psychiatry and CME has been applied for through the American Academy of Family Medicine. Any clinician may register and attend the face-to-face training, however, only medical doctors and doctors of osteopathic medicine may obtain the waiver to prescribe.

CHAMPS 2013 Immunization Update Teleconference

On July 31, 2013, over 100 health center staff participated in the annual **CHAMPS Immunization Update Teleconference.** Andrew Kroger, MD, MPH of the Centers for Disease Control and Prevention (CDC) presented current immunization recommendations from the Advisory Committee on Immunization Practices (ACIP). The live teleconference offered 1.25 Continuing Medical Education (CME) credits. Highlighted recommendations included:

- ★ Meningococcal vaccination (Hib-MenCY)
- ★ New MMR recommendations
- ★ HPV vaccine
- ★ Tdap (pregnancy)
- ★ Influenza vaccines
- ★ PCV13 (vaccination of high-risk adults)
- ★ Storage and handling
- ★ Vaccine administration

Updated Region VIII Demographics Data Summary

CHAMPS recently updated the **Region VIII Demographics Data Summary**. The summary provides useful statistics on population, race, disability status, poverty rates, education levels, and income levels for each Region VIII state with comparisons to national data. Interesting trends include the shrinking of the under five year population and growth of the over 65 years population both nationally and in Region VIII. The population of Region VIII experienced more growth than the nation's population from 2011 to 2012, and the percentage of the Region VIII population that speaks a language other than English at home continues to grow. CHAMPS also offers **Region VIII Data Summaries on Mortality, Behavioral Health, and Women's Health**.

HRSA PIN on Budgeting and Accounting Requirements

The Health Resources and Services Administration (HRSA) released Policy Information Notice (PIN) 2013-01: *Health Center Budgeting and Accounting Requirements* on June 13, 2013. This PIN provides information about budgeting and accounting requirements for health centers and their applicability to section 330 federal grant funds versus non-grant funds.
