#### Welcome New CHAMPS Executive Committee Members

The CHAMPS Executive Committee is made up of officers and state representatives elected from the CHAMPS Board of Directors, plus the current Chair of the Mountain Plains Clinical Network (MPCN) Steering Committee. Executive Committee members serve a two year term; the current Executive Committee was elected in October 2008 and will serve until October 2010. Two Executive Committee members have recently



stepped down from their duties, Secretary Gina Flanagan of Wayne Community Health Centers in UT and North Dakota Representative Aaron Garman, MD, of Coal Country Community Health Centers. **Donna Singer**, Executive Director of Utah Navajo Health Systems in Montezuma Creek, UT, has been appointed as Utah Representative through October 2010, and **Dawn Berg**, Executive Director of Coal Country Community Health Centers in Beulah, ND, will fill the unexpired portion of Dr. Garman's term. Also, the MPCN Steering Committee recently underwent elections for the Chair and Co-Chair positions of that committee (see page 6 for more details). **Keith Horwood, MD**, Medical Director of Community Health Centers, Inc. in Salt Lake City, UT was elected as the new MPCN Steering Committee Chair, and therefore has a seat on the current CHAMPS Executive Committee, replacing previous Chair Jim Guyer of RiverStone Health in Billings, MT. As a part of the reorganization, **Cathy Keene** of Wind River Health Systems in WY has moved from Wyoming Representative to Secretary.

## Funding Supports Region VIII CHCs

In early December 2009 President Obama announced \$600 million in American Recovery and Reinvestment Act (ARRA) funds would be awarded to community health centers (CHCs) to support construction and renovation projects, adoption of Electronic Health Records (EHR) and other Health Information Technology (HIT) systems, and to promote the medical home model. It is estimated these improvements will help CHCs serve 50,000 more patients nationally in addition to creating new jobs in the healthcare industry.

# 2004-2008 Region VIII Uniform Data System Summary

In late November, CHAMPS released the **2004-2008 Region VIII BPHC Uniform Data System (UDS) Summary**. This summary is comprised of a five year regional history of CHC users, staffing, encounters, and income information, and includes a *new section addressing selected CHC financial performance measures*. The publication includes:



- ★ Comparison of Region VIII and national figures regarding total cost per patient and medical cost per medical encounter over a three year period
- ★ Select factors relating to these performance measures including, special populations, user language preferences, and enabling services, with comparisons to overall encounters, patients, and revenue
- ★ State breakdowns for all of the information described above

## Now Available: JOB Data Comparison Report

The CHAMPS online **Job Opportunities Bank (JOB)** is a free resource advertising career opportunities in Region VIII community, migrant and homeless health centers and state Primary Care Associations. Each February, CHAMPS assesses the data submitted by the posting organizations to create comparison reports of the CHC-specific data from year to year. These annual



reports illustrate recruitment efforts and trends throughout Region VIII, including types of positions recruited, average recruitment lengths, and successful recruitment resources.

Highlights from the newly released **Region VIII Job Opportunities Bank (JOB) Data Comparison Report** include:

- ★ Forty-two different Region VIII CHCs advertised 224 career opportunities on JOB during the 2009-2010 period, a **20% decrease in posted CHC positions** from the 2008-2009 period.
- ★ Average recruitment lengths for all filled positions at Region VIII CHCs have decreased slightly overall from 8.3 months in the 2008-2009 period to 7.2 months in the 2009-2010 period.
  - For this report, CHAMPS has added a NEW section looking more closely at recruitment lengths for specific filled clinical positions. During the 2009-2010 time period:
    - Filled Dentist and Dental Director positions were advertised for an average of **9.8 months**.
    - Filled Physician and Medical Director positions were advertised for an average of 13.8 months.
    - Filled Physician Assistant, Nurse Practitioner, and Certified Nurse Midwife positions were advertised for an average of **8.1 months**.
- ★ The most commonly cited successful recruitment resources this year were "Online Listing", "Local Referral/Word of Mouth", and "Hired Former Employee/Intern/Extern/Resident".

### Expanded Availability of Loan Repayment Awards



The National Health Service Corps (NHSC), through the American Recovery and Reinvestment Act (ARRA), has expanded its program to include loan repayment of up to \$145,000 for five years. This new program requires the two year commitment of the previous program, but then gives the option of adding additional years (up to five total) for additional loan repayment (up to \$145,000).

total). The additional years are eligible for those currently enrolled in the two year program, clinicians who are mid-career but still have loans, and clinicians who are new to NHSC. With ARRA funding NHSC is increasing access to loan repayment for clinicians working in NHSC-approved sites with HPSA scores as low as zero. Four thousand new NHSC clinician spots are available, for which applications will be accepted through July 29, 2010. NHSC also has a **Recruitment Training and Support Center (RTSC)** available to assist health centers in recruiting NHSC clinicians.

### MPCN New Leadership Needs You!

Mountain/Plains Clinical Network (MPCN) is a program of CHAMPS that includes all health care providers working in Region VIII community health centers and National Health Service Corps (NHSC) participants working in Region VIII. MPCN members are represented by the MPCN Steering Committee.

The MPCN Steering Committee meets by conference call every other month, and also meets face-toface annually. Most recently the Steering Committee met at the CHAMPS/NWRPCA Annual Primary Care Conference in October to develop a strategic plan for MPCN for the next two years.

During the strategic planning process, Steering Committee members (up to two clinical representatives from each of the six states in Region VIII) decided to expand the Steering Committee membership to provide better representation of all providers in Region VIII. Steering Committee may now include up to four representatives from each of the six states in Region VIII (CO, MT, ND, SD, UT, WY) including:

- **★** Two medical providers
- ★ One oral health provider
- ★ One behavioral health provider

So, the MPCN Steering Committee needs you! All six states have various positions available now on the MPCN Steering Committee. Serving on the Steering Committee is a great chance to give your input into the

### Harvard Managing Ambulatory Care I Training

CHAMPS and the Northwest Regional Primary Care Association (NWRPCA) are hosting the Harvard School of Public Health's Managing Ambulatory Care I course, to be held in conjunction with the NWRPCA Spring 2010 Conference May 20-23, 2010 in Portland, OR. The training was developed to enhance the leadership skills of physicians, medical directors, and clinical managers working in community clinics throughout the Western US. Core competencies addressed in this program are:

- **★** Financial management
- ★ Enhanced role of the medical director
- **★** Clinic operations

- ★ Managing people
- ★ Political issues and community leadership

The Harvard case method of instruction will be used to facilitate practical application of the concepts presented and to create a dynamic forum for the exchange of insights and experiences. Tuition is \$1,600 plus a \$100 materials fee if paid before March 1, 2010. A deposit of \$500 per participant is required to reserve a space. The balance of \$1,200 is due by March 1, 2010. Tuition is \$1,700 plus \$100 material fee if paid after March 1, 2010.

### Spanish Language Training for Health Professionals

CHAMPS is partnering with Ríos Associates and the Denver Medical Society (DMS) to offer a four-day intensive **Spanish Language for Health Care Professionals training**. This course is designed for physicians, nurses, PAs, NPs, medical assistants, dentists, pharmacists, and other medical personnel and is accredited for

45 continuing medical education (CME) hours. Two skill levels will be offered, with separate classes for each skill level. Both sections will include interactive dialogues, role-plays, colorful visual aids, cross-cultural discussions, "edutainment", daily practice, and evening study with work-books and CDs. The course is designed to provide an immersion experience, and participants who complete the course will:

- ★ Obtain or enhance their ability to interview patients in Spanish, take a medical history, conduct a physical exam, give prescriptions and follow-up instructions, and intervene with medical emergencies.
- ★ Be exposed to at least 1,500 general and medical Spanish words.
- ★ Communicate confidently in present, future, and past tenses, as well as the command forms.
- ★ Gain awareness of cultural differences and attitudes between Latinos and other Americans regarding time, space, clothing, foods, health, and medical care.
- **★** Develop skills to continue learning Spanish through daily practice and personal experience.
- ★ Intermediate students will be able to do everything above in addition to using additional idioms, complex tenses and moods (conditional, present and past progressive, present and past perfect tenses plus subjunctive mood and its tenses).

The workshop will be held from May 21–24, 2010 in Denver, Colorado. The registration fee is \$499 for CHAMPS and DMS Members and \$599 for Non-Members. Cost includes four days of instruction, course work book and CDs, CME credit, and snacks.

#### New Aetna Foundation Funding Focus Areas

The Aetna Foundation has awarded over \$359 million in grants and scholarships since 1980. In the past the focus of these grants has varied, but starting this year the Aetna Foundation has narrowed its funding focus areas to those facilitating improvements in health and healthcare through:

- ★ Addressing the high rate of obesity in the US
- ★ Reducing racial and ethnic disparities regarding infant mortality and common chronic conditions
- ★ Promoting integrated health care that includes good communication between providers and educated/involved patients resulting in high-quality and cost-effective care

### Should the US Adopt the Dental Therapist Model?

According to a report released by the W.K. Kellog Foundation (WKKF) in December of 2009 titled **Training New Dental Health Providers in the US**, the United States is beginning to adopt the dental care system that has been implemented internationally to increase access to care and reduce dental costs. This system relies on the work of dental therapists to perform basic and preventative duties formerly performed exclusively by dentists.

The role of a dental therapist is comparable to the role of a nurse practitioner or physician assistant in the medical field. The dental therapist model started in 1920 in New Zealand has since expanded throughout the world, and now exists in such countries as England, The Netherlands, and Australia; the model is already present in some US communities. In 2003 Alaska piloted a dental therapist model in rural underserved communities, and in early 2009 Minnesota enacted a law allowing for dental therapists. WKKF postulates that the implementation of the dental therapist model would alleviate the gaps present today in dental care.

# Colorado Workforce Collaborative Prepares for Spring Legislative Session

Funded by The Colorado Trus t, the **Health Professions Workforce Policy Collaborative (HPWPC)** has prepared a package of policy recommendations intended for consideration during the 2010 Colorado legislative session. HPWPC is comprised of more than 20 organizations,



including Colorado Community Health Network, Colorado's Primary Care Association (PCA), Colorado Rural Health Center – the State Office of Rural Health, and other member associations, foundations, and educational institutions. HPWPC has worked since summer 2008 to develop a strategic agenda to support and advance key health care workforce solutions.

The policy recommendations were presented at the 2<sup>nd</sup> Annual Colorado Health Professions Workforce Summit on October 22<sup>nd</sup>, and were a huge success. One bill has been announced that would expand state loan repayment programs for health care providers working in underserved areas of Colorado to include dentists and dental hygienists. The bill would also remove the loan amount minimum of \$35,000 and streamline all existing loan repayment programs into a one-stop-shop structure.

#### Health Center Site Visit Guide Released



The Health Resources and Services Administration (HRSA) released the **Health Center Site Visit Guide** in November 2009. This guide is used to evaluate how well organizations adhere to HRSA's section 330 Health Center Program requirements, and can be used as a resource for Health Centers to self-evaluate if they are in compliance with the requirements or improving their performance.

### HRSA Reorganizes Offices

In an effort to increase impact and improve efficiency, the Health Resources and Services Administration (HRSA) has established the **Office of Special Health Affairs (OSHA)** and appointed **Donald Weaver** as the director of this new office. Within OSHA there are three distinct branches: the Office of Global Health Affairs, the Office of Health Equity (formerly the Office of Minority Health and Health Disparities), and the Office of Strategic Priorities.

- ★ The Office of Global Health Affairs has consolidated the global health efforts of the Office of International Health Affairs and the Office of Commissioned Corps Affairs. The new structure was created so that one office can concentrate exclusively on all global health efforts.
- ★ The Office of Health Equity changed its name to reflect more accurately its current purpose.
- ★ The Office of Strategic Priorities was developed to deal with up-and-coming issues. It is currently working on HRSA's oral and behavioral health initiatives.



In addition, the Office of Equal Opportunity and Civil Rights has been changed to the **Office of Equal Opportunity**, **Civil Rights and Diversity Management**, and the quality and health information technology grants and initiatives are now being overseen by new bureaus.
