Critical Skills for Mid-level Managers is a six-month hybrid in-person and virtual training for new and experienced mid-level CHC managers. This unique training will help clinical and operations leaders join together as a team at a time when Patient-Centered Medical Home accreditation pushes health centers to operate team-based health management. CHCs can enroll a **two-person team: one clinician and one operations leader**, to develop side-by-side in practical application and ongoing process improvement. The training will be taught by two Harvard faculty, Paul Campbell, MPA, ScD and Dr. Robert Hoch, MPH, who have run executive education programs at Harvard for 25 years.

The course fee is **\$3,500 per team for CHAMPS members**. In early December 2011, CHAMPS sent an online survey to staff of all disciplines at Region VIII's 57 health center organizations. The **Region VIII Health Center Recruitment and Retention Survey** gathered information to help CHAMPS, Region VIII State Primary Care Associations, and participating health centers assess existing offerings and design new programs specifically supporting the successful staff recruitment and retention. With more than **1,200 support staff**, providers and executive leaders providing input the response was a

providers, and executive leaders providing input, the response was overwhelming!

An electronic report of this valuable information will be released in early March and will:

- **Include Baselines** for tracking workforce characteristics over time (e.g., gender, age, years of employment, fluency, etc.)
- **Provide valuable recruiting information**, including the most useful and commonly used resources for seeking employment, the most common reasons why employees decide to work for a health center, where employees came from before being hired by their health center, etc.
- Identify Region VIII health center successes and weaknesses in terms of staff satisfaction, with the goal of determining the best ways to promote the health center model of care, and to illustrate the areas where grantees, CHAMPS, and the SPCAs might most effectively and efficiently augment and improve their programs and services
- Anticipate upcoming turnover and identify the reasons people may be planning to leave

## Sharing Human Resources Information across the Nation

Health centers can easily access and share their knowledge and best practices on the National Association of Community Health Centers' (NACHC) new Human Resources (HR) Clearinghouse. Clearinghouse is a searchable database developed by NACHC and health center and PCA HR staff to support information sharing nationally. The HR Clearinghouse houses policies and procedures, best practices, surveys, eLearning and training opportunities, and more. There are more than 150 resources added by health center peers already available on topics such as benefits, credentialing, diversity and job descriptions.

#### **Human Resources Tool:**

#### Core Competencies for a Stronger Workforce

Hiring and assessing a workforce with a specialized skill set can be difficult, but the Council on Linkages between Academia and Public Health Practice developed a tool kit that more than half of state health departments are currently using to bridge the gap between academia and practice. The Core Competencies for Public Health Professionals is a set of standards developed by academic institutions and professional organizations that health centers can use towards for workforce development including assessing knowledge and skill gaps, crafting job descriptions, or implementing performance reviews. They are divided into a three tier continuum that describes the skills necessary for each level of staff: entry, management, and senior staff (see box on the right).

**Tier 1-**Entry level staff Competency example: "Skills to identify the health status of populations and their related determinants of health and illness"

**Tier 2-**Supervisors and managers Competency Example: "Can assess the health status of populations and their related determinants of health and illness"

**Tier 3-**Senior managers and CEOs Competency Example: "Can *review* the health status of populations and their related determinants of health and illness"

## CHAMPS UpToDate Group Purchasing Offer Available Again!

The CHAMPS UpToDate Group Purchasing Offer (GPO) will **re-open April 1, 2012**. UpToDate is an evidenced-based, peer-reviewed information resource available to healthcare providers on computers and most mobile devices. It can be used as a point of care decision making device or as a research tool that allows providers to earn continuing medical education (CME) credits for literature reviews.

During 2011, 11 CHAMPS member health centers took advantage of the GPO and **saved hundreds of dollars** on individual subscriptions of UpToDate. Although UpToDate raised rates across the board in February 2012, CHAMPS was able to negotiate a new GPO. From April 1-December 1, 2012, CHAMPS member health centers can purchase any number of individual provider subscriptions for \$80 off

the retail price per subscription. The CHAMPS GPO price per subscription is \$419 (with a one-time \$15 processing fee) compared to the retail rate of \$499. In addition, subscribers can renew in 2013 for \$419 with no processing fee. This is a savings of \$30 over the retail renewal rate of \$449.

The CHAMPS UpToDate GPO is best for health centers with less than 20 providers. Large health centers with at least 20 providers may want to consider the UpToDate Enterprise product (institutional subscription) which allows all health center providers to access UpToDate within the health center's Electroic Health Record (EHR). The Enterprise product costs \$395 per provider with a minimum purchase of \$8,000.

## Reproductive Health Access Project:

Contraceptive Pearls Help Keep Clinicians Informed

The Reproductive Health Access Project (RHAP) recently began offering Continuing Medical Education Credit (CME) from the American Academy of Physicians for their email publication, **Contraceptive Pearl.** The publication highlights evidence-based clinical practices to educate family physicians about contraceptive care. RHAP provides clinical tools, scientific publications, and patient-centered educational information on their website and through the publication. Recent Contraceptive

Pearls included an *Emergency Contraception Clinician Guide, Progestin Implant Update,* and information about *Contraception for HIV Infected Women.*

### ICD-10 Transition: Possible Timeline Extension

The switch to ICD-10 from ICD-9 diagnosis and procedure codes takes effect on October 1, 2013, but the acting head of the Centers for Medicare and Medicaid Services (CMS) recently stated that the timeline may be extended. Providers should have already begun testing the Version 5010 transaction standards by January 1, 2012. Marilyn Tavenner told reporters last week that CMS may extend the deadline for implementation due to the challenges of competing priorities with meaningful use and preparing for exchanges. The new codes are alphanumeric and are more descriptive than the ICD-9 codes.

## AHRQ Launches Regional Partnership Development Initiative to **Promote Patient-Centered Outcomes Research**

The Agency for Healthcare Research and Quality (AHRO) recently launched efforts to promote patient-centered outcomes research (PCOR) in patient and professional communities in all 50 states. AHRO has established five Regional Development Partnership Offices that are cultivating sustainable partnerships with hospitals health systems, patient organizations, businesses, and other groups that serve clinicians, consumers, and policymakers. CHCs are invited to learn more about PCOR and to partner with AHRQ by using free PCOR reports and materials that support efforts to improve the quality of health care in communities.

PCOR provides information to help clinicians and patients work together to treat an illness or PCOR compares drugs, medical condition. devices, tests, surgeries, or ways to deliver health care. The research findings don't tell clinicians how to practice medicine or which treatment is best, but they provide evidence-based information on the effectiveness and risks of different treatments. Clinicians and patients can use this information to make informed treatment decisions based on each individual's circumstances.

AHRQ's Effective Health Care Program works with researchers, research centers, and academic organizations to conduct the research and focuses on 14 priority health conditions, including: cardiovascular and related diseases, diabetes, arthritis, mental health disorders, and pregnancy. Organizations that are using the PCOR findings include Mayo Clinic, the American Academy of Nurse Practitioners, and AARP, among many others.



## NHSC Loan Repayment Now Tied to HPSA Scores

The National Health Service Corps (NHSC) recently opened their Loan Repayment Program (LRP) application cycle with a significant change: loan repayment amounts are now based on the Health Professional Shortage Area (HPSA) score at the provider's health center. Providers at sites with HPSA scores of from zero to 13 are eligible for \$40,000 for a full-time two-year commitment. Clinicians at sites

with HPSA scores of 14 and higher are eligible for up to \$60,000 for a full-time two-year

commitment.

## Medicaid.gov Launched

SERVICE

The Center for Medicaid and the Children's Health Insurance Program Services (CMCS) launched a new website, Medicaid.gov, devoted to information and policies about CMCS. The website provides resources, frequently asked questions, Federal policy guidance, State-specific program information, and information about the Affordable Care Act implementation.
