In January 2013, RCHN Community Health Foundation awarded five one-year grants, totaling nearly one million dollars, as part of their Health Center Entry-Level Workforce Recruitment and Retention Initiative. One of the five grantees was **Salud Family Health Centers**, Fort Lupton, CO.

Health Centers Provide Vital Input about Training Needs

In late December and early January CHAMPS and Region VIII's State Primary Care Associations (SPCAs) distributed the **2013 Region VIII Health Center Needs Assessment** to leadership staff at the region's 62 health center organizations. Well over 200 people from 95% of the region's health centers responded, providing information about their center's need for training and technical assistance (T/TA) in:

- **★ Program Requirements** in the areas of Need, Services, Management & Finance, and Governance; 11 (of 109) topics ranked as high need for T/TA, including:
 - o ICD-10 Preparation
 - Coding Education
 - Supervisor/Manager Training
 - o PCMH Training
 - Leadership Development
 - Productivity Benchmarking

- Coding Auditing
- Succession Planning
- PCMH Continuous Team-Based Healing Relationships (Care Teams)
- Understanding and Utilizing Data Effectively
- Billing Best Practice
- **★ Clinical and Financial Performance Measures**
 - o Clinical Measures with the highest need for support via T/TA were:
 - Controlled diabetes (HbA1c levels)
 - Cervical cancer screening (including PAP test)
 - Weight assessment and counseling for children/adolescents
 - Financial Measures with the highest need for support via T/TA were:
 - Total cost per patient
 - Medical cost per medical visit
- ★ **Additional Areas** including collaborative relationships, emergency preparedness, health reform, and more; three (of 19) topics ranked as high need for T/TA, including:
 - New Payment Models
 - o Medicaid Expansion
 - Insurance Exchanges

CHAMPS and each Region VIII SPCA will be using these results, as well as more in-depth analysis of various topics, to update current programs and services, identify new areas for T/TA, and further guide short- and long-term planning in support of successful health centers.

CHAMPS thanks Region VIII's SPCAs (AUCH, CCHN, CHAD, MPCA, and WYPCA) for their vital collaboration on this project!

Additional thanks to the survey respondents – your input is fundamental to ensure CHAMPS and the SPCAs can provide the most effective support possible.

EHCI: Linking Health Centers with Family Medicine Residencies

A growing number of health centers are developing their future physician workforce while serving their clients by working with Family Medicine Residency (FMR) programs or establishing their own FMR. The **Education Health Center Initiative (EHCI)**, jointly sponsored by CHAMPS and Northwest Regional Primary Care Association (NWRPCA), has been providing consulting assistance to health centers and Family Medicine Residencies since 2011. In the past year, EHCI was pleased to assist health centers in CA and IA in winning approval for residency slots under Round 3 of HRSA's **Teaching Health Center Graduate Medical Education (THCGME)** program. RiverStone Health, a CHAMPS member based in Billings, MT and an exemplary Teaching Health Center (THC), also was awarded a THC grant in the first round. Currently, EHCI is working on a project with The George Washington University to evaluate the efficacy and cost-effectiveness of Family Medicine Residency programs funded with THCGME funds compared to more traditional Graduate Medical Education (GME) mechanisms.

Now Available: Updated Region VIII Data Summaries on Mortality, Behavioral Health, and Women's Health



CHAMPS has recently updated the Region VIII Data Tables on Mortality, Behavioral Health, and Women's Health. These data summaries provide useful statistics from each Region VIII state with comparisons to national data. The **Mortality Data Summary** includes information about death resulting from different diseases, accidents, and assault. The **Women's Health Data Summary** includes statistics on preventive health such as disease rates and screenings and reproductive health including birth rates and delivery methods. Lastly, the **Behavioral Health Data Summary** contains information on adult and youth behavioral and social determinants of health. Interesting changes

from the previous year include a drop in the teen birth rate for all RVIII states and nationwide (Women's Health), a drop in the death rate for chronic lower respiratory diseases for the nation but an increase in all RVIII states (Mortality), and increases in the rates of both heavy alcohol consumption drinkers and binge drinkers in all RVIII states and nationwide (Behavioral Health).

Increasing the ability of Region VIII Health Centers to effectively serve populations with limited access to health care by increasing knowledge and enhancing collaboration

Introduction to CHAMPS Special Populations Activities and Resources

To address the health care needs of specific populations, the US Health Resources and Services Administration (HRSA) designates funding for health centers to serve migrant and seasonal farmworkers, individuals and families experiencing homelessness, those living in public housing, and



Native Hawaiians. Additionally, HRSA supports other special populations groups through Cooperative Agreements with state, regional, and national organizations that provide services supporting the provision of excellent health care for the populations listed above as well as for school-based health care, care for elderly and LGBT populations, and oral health. To keep Region VIII abreast of the everchanging needs and issues important to these groups, CHAMPS is **implementing new venues for distributing resources to assist health centers in successfully serving special populations**, including this new section of the newsletter, expanded website resources, and postings on social media.

The updates communicated in the PAL are intended to better align the CIS submission and review processes with existing Health Center Program scope of project policies.
