## PPC 5: ELECTRONIC PRESCRIBING Element A: Electronic Prescription Writing

CHC-B knows it is important to reduce medical errors and improve efficiency by eliminating handwritten prescriptions and by using drug safety checks and cost information when prescribing. We use an electronic prescription writer that is linked to patient-specific demographic and clinical information within our EMR. Our system, EHS, provides an enhanced ERx module within the electronic chart. Providers enter and renew all (100%) prescriptions within the medication module of EHS. This report shows the date, medication, prescriber, pharmacy, unique patient #, and count of all prescriptions written in the last 3 months. (9,716 out of 9,716 prescriptions were written using the electronic prescription writer for 100% using Item 2). In the last 3 months, CHC-B' providers wrote 9,716 prescriptions for 2,403 patients using 27 different pharmacies.
